Aisling Annacotty AFC is a Soccer Club providing sporting activities and opportunities for children and young people through participation through sport. Aisling Annacotty AFC offers sporting activities to children and young people from the age of 6. Aisling Annacotty AFC recruits over 100 volunteers with over 1000 participants. Aisling Annacotty AFC is committed to safeguarding children and by working under the guidance of our Safeguarding Policies and procedures, our staff, both volunteers and employed working with our children and young people, throughout the Association, seek to create a safe and fun environment for children and young people to participate in their sport.

Principles to Safeguard Children from Harm

Principles to Safeguard Children from Harm This statement recognises that in accordance with legislation and the requirements of FAI Handbook, FAI Child Welfare and Safeguarding policy, other FAI policies and procedures that the welfare and interests of children are paramount in all circumstances. Aisling Annacotty AFC is established on a number of core principles: - the needs of the Child, integrity and respect, environment, equality, fair play, welfare and safety in football. These underlying principles underpin our rules, policies and procedures to ensure that when Children participating in our activities, they do so, as far as is practicable, in a safe and enjoyable environment.

Risk Assessment

In preparing this statement Aisling Annacotty AFC have completed a Risk Assessment of the potential risk of harm to children when they are participating in any of our games and attending our activities. The risks were reviewed under the following headings; Club and Coaching Practices; Complaints & Discipline; Reporting Procedures; Use of Facilities; Recruitment; Communications; and General Risk of Harm. 
